COORENOR is a three-year project co-funded by the Public Health Programme of the European Commission and the Project Associated Partner.

AIM

COORENOR Project aims to establish a Coordinated Network between national programs existing in the field of organ transplantation, taking into account some major issues such as cadaveric donation, living donation and organ exchange.

All project activities will foster coordination of efforts of countries from Eastern and Western Europe, all having different approaches and programs to tackle the issues of organ procurement and transplantation.

INFORMATION ON PROJECT STRUCTURE

The work to be performed in COORENOR is organized in three horizontal work packages (WP) and four core work packages, as showed in the figure. The coordination of the project relies on the CNT (Italy).

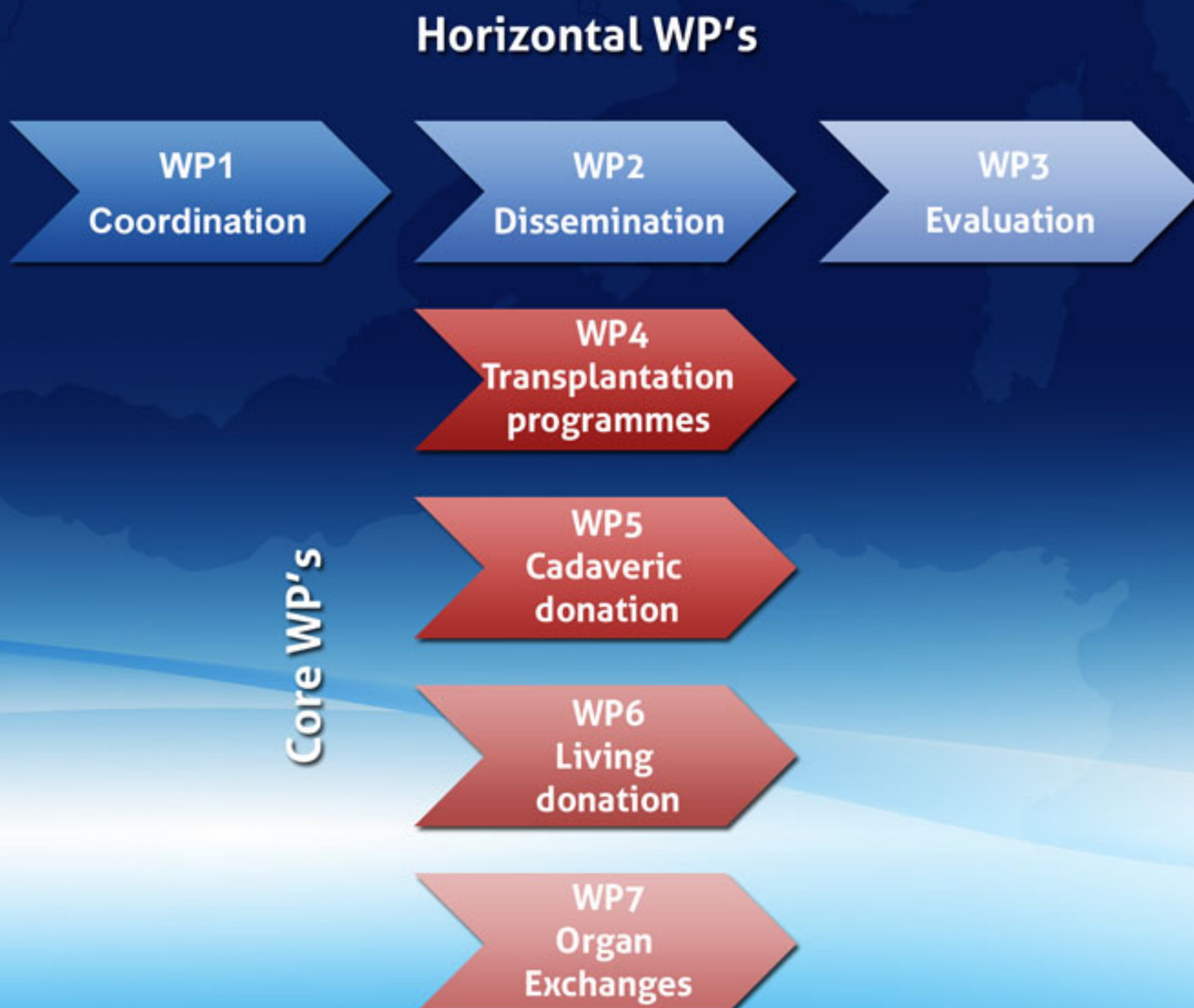
SPECIFIC OBJECTIVES

WP1 Coordination of the project (CNT)

The Project Manager is in charge of the overall management of the project and is responsible for the correct execution of the contract. He is also the main interface to both the European Commission and the outside world.

WP2 Dissemination of the project (OVSz)

Dissemination plan describe the methods to ensure smooth communication flow among partners, mainly by the webpage, meanwhile each partner will be responsible for dissemination of the project in their own country to present the project and its results to experts in the field and communicating the findings to relevant stakeholders.



WP3 Evaluation of the Project (Poltransplant)

This WP focuses on ensuring that high quality deliverables are produced by the project and validating that project outputs are fit for purpose.

WP4 Investigating, comparing and benchmarking national / regional transplantation programmes (ABM)

Overview of supranational/national/regional/local transplant programmes in EU and analysis of organisational systems: recommendations on further initiatives and future work.

WP5 Cadaveric donation (CNT)

Analysis of cadaveric donation procedures in participating countries and analysis of public campaigns: recognition of different donation procedures in participating countries, benchmarking and laying down of recommendations. Analysis of the impact of public campaigns to increase donation from cadaveric donor.

WP6 Living donation (MUW)

Analysis of living donation procedures: recognition of different living donation procedures in participating countries and room for expansion of the donor pool, benchmarking and laying down of recommendations.

WP7 Cross Border Organ Exchange (KST)

Analysis of cross border organ exchanges: study protocol of ongoing organ exchanges in consortium countries and collaborating partner, together with features and requirements for the creation of a web portal to serve international collaboration dedicated to organ exchanges.

PROJECT OUTCOMES

The harmonization and coordination in defining the best common practices and guidelines.
An increasing involvement of collaborating partners and external partners.

To define a study protocol on the cross border organ exchange.

To achieve a more active promotion on living donation across Europe especially in countries where this practice is not well developed.
